Dear ADRA friends and supporters,

In this financial year, the ADRA network adopted a new purpose statement to succinctly expound our role as the global humanitarian organisation of the Seventh-day Adventist Church present in more than 118 countries:

"To serve humanity so all may live as God intended — free from poverty and disadvantage."

This purpose statement clearly indicates that ADRA is about undoing injustices and about the restoration of peoples dignity and hope. This statement is fuelled by faith which drives and inspires the organisation in the pursuit of compassion and love for all, regardless of any condition or affiliation. It also identifies ADRA as an organisation dependant on God, its supporters and volunteers, its church, and its global partners.

This year was marked by some significant milestones in ADRA New Zealand's international programmes. In partnership with the New Zealand Ministry of Foreign Affairs and Trade (MFAT), ADRA started a new 5-year agricultural initiative in Cambodia to equip almost 10,000 farming families to not only grow enough produce for consumption but to effectively engage in the market. In addition, a new water, sanitation, and hygiene project was also approved to assist 5 communities in Vanuatu. These new initiatives add much scope and volume to ADRA's existing portfolio impacting more than 95,000 lives in Timor-Leste, Myanmar. Bangladesh, Indonesia, Samoa, Papua New Guinea and the Philippines.

Nationally, ADRA through ongoing partnerships with churches, philanthropic and other community organisations, implemented 51 initiatives involving more than 2,500 volunteers and assisting hundreds of families to improve their lives through depression recovery, parenting skills, driver licences, finance management, and youth resilience programmes. None of these could have happened without Community Champions which ADRA, in partnership with Adventist Health and Discipleship, is equipping through training workshops throughout New Zealand.

The objectives of ADRA's Strategic Execution Plan were met for the year in the areas of programmes, corporate services and marketing. ADRA New Zealand also established productive partnerships with other ADRA offices around the world and MFAT to leverage the support received from generous New Zealanders so that more people could be assisted.

Thank you for being there for the families and communities we served this year!

STRONGER TOGETHER IN SUPPORT

COROMANDEL CLASSIC

Earlier in 2019 a group of 22 supporters undertook the challenge to cycle 300km raising money to support ADRA New Zealand.

We set out from downtown Auckland and cycled 100km each day to reach Coromandel township... raising over \$75,000 for ADRA's work on Cambodia in the process.

The 22 of us were joined by people riding for ADRA Australia as well as a few other charities to make 65 riders in total. Together we shared early mornings, laughter, miles covered, and above all else, a desire to help some of the most vulnerable in our world.

Cycling that distance is quite an undertaking. We helped each other fix punctures, keep morale up, and ensure that everybody made it to the next stop. We showed how we were stronger together as riders, all the while standing together to help vulnerable farmers in Cambodia.

Thanks to the support of the NZ Government match scheme, the money raised has been magnified 4 times.

ADRA RUN

As we were preparing for the Annual ADRA Run Indonesia was hit by a devastating earthquake and tsunami.

The funds raised at the run were originally destined to support our long term development project in Timor-Leste, but we knew we had to respond to help the hundreds of thousands of people who were suddenly without clean water, food or shelter in Indonesia.

So we put the call out that the Run would now support this cause and people responded by opening their hearts and standing together with the people of Indonesia who were affected by this devastating event.

Over 500 eager runners and walkers came along to Mission Bay early Sunday morning 14th October 2018 to run, raise funds and show their support. Together we raised a fantastic \$66,000!

NO TURNING BACK FOR YOUNG EMMANUEL

Earlier in the year, Sahara travelled to Vanuatu to monitor the progress of the Water, Sanitation and Hygiene project implemented by ADRA Vanuatu for the last four years and shared the following reflection:

One of my most challenging and memorable experiences of my Vanuatu trip was doing a 9-hour hike alongside a young boy named Emmanuel.

Emmanuel is 8 years old and was one of

the 4 crew members that led us to each water source we were inspecting that day. He hiked with ease and I crawled my way up the mountains. After two hours of hiking. we made it to the first water supply source in Elia.

If you could see what I had seen, it would have broken your heart too. The community of Elia

were drinking from an irrigation channel. The water was dirty and contaminated making the local community vulnerable to disease, but there was no other alternative.

We spent the next 4 hours walking to the next water source. I had thought many times of turning back. It had been

pouring rain since we started walking, I was soaked, tired and weak. Every muscle and bone in my body was aching but every time I turned around to see how far we had walked. I would see Emmanuel. right there behind me. Sometimes smiling

and sometimes looking "I was soaked, tired concerned.

As we were walking I asked Emmanuel. grace next to me while **muscle and bone in** "Which of these men is your father"? He replied, my body was aching "None of them, my father died when I was 6 years old". After learning this I was reminded of ADRA's purpose and of why I was on this 9-hour trek through the bush walked, I would see — so that children like Emmanuel could have clean water and live a healthier life!

ENDERLEY CREW RESTORATION PROJECT

The Enderley Crew Restoration project is a youth mentoring programme where young people are mentored through the hands-on process of restoring salvaged bicycles. Enderley is a low socio-economic community in Hamilton East, where many families are struggling. The opportunities this programme provides for young people have not only been embraced, but also really appreciated. The programme provides children with the opportunity to participate in positive, affirming activities each week after school and develop strong relationships with each other and their mentors. Sound interesting? I thought so too! So, I headed off to Hamilton with a few colleagues to visit Israel the project leader, and his amazing team in action!

Israel O'Dea did not have it easy growing up and as a result, ended up in a gang living a life of crime and substance abuse. Israel turned his life around and dedicates a lot of time and effort into mentoring these children who otherwise have very little positive influences around them. Running the project is not always easy for Israel as he has faced a number of health issues. He had cancer at

a young age, and now lives with muscular dystrophy. Israel doesn't always feel well as he gets easily tired and is always in pain, but despite this, he shows up weekly to run the project. "The joy and sense of fellowship and community with these kids is literally restoring me", he says. Israel's heart or compassion and love for his community and young people sees him determined to be present weekly,

along with all the other volunteers.

Israel wishes there had been a programme like this when he was growing up, as he believes it would have had a huge impact on the way that he dealt with his problems at home. This remains a great motivation for him, alongside his love and passion for the children who are often forgotten.

Through learning about bicycle maintenance and restoration as well as road safety, youth are equipped with skills and values that can counter the negative influences within their high-risk community. Pastor Mike of Hamilton Eastside SDA Church shares that this initiative is helping high-risk youth/children by equipping them with practical skills and good relationships with their mentors, empowering them to make wise and positive choices.

After the work is done, the young people take turns riding the bikes that they've restored. Then the evening ends with a game or two, before grace and a healthy vegetarian meal together prepared by Lori (Pastor Mike's wife).

It's clear to see the solid relationships that have formed between the team and the young people in the community. The youth feel comfortable and safe to be themselves and are having fun learning and developing new skills. Pastor Mike shares how lovely it is when they are out and about in the community, and kids run up to them and hug them saying to their parents – these are the people that give us kai and aroha (kai — food, aroha — love in Māori).

Thank you to Israel, Joe, Pastor Mike, Lori and all the amazing volunteers whose compassion and love for their community, sees them taking quite a few hours out of their own time every week to run this wonderful community initiative! ADRA would like to acknowledge and thank you for all you've done and continue to do. Your compassion and love to transform lives and help our communities thrive is greatly appreciated! THANK YOU!

STRONGER TOGETHER IN COMMUNITY

This is our seventh year serving as pastors for the South New Zealand Conference (SNZC). We spent 4 years in Invercargill and are now in our third year in Christchurch. During this time, it has been a great blessing to partner with ADRA in running various community projects.

In 2012, in one of her speeches, Michelle Obama said, "Success isn't about how much money you make; it's about the difference you make in people's lives." ADRA has helped us do exactly this. We have seen lives transformed and people thrive. This would not have been possible without the help of ADRA through its Community Transformation Partnership (CTP) initiatives. We not only received financial help but mentoring as well to run the community projects.

Over these seven years, we have run various community projects (e.g. Discover your Missing Link, Turning Point, CHIP, Depression Anxiety and Recovery, Accelerate Workshops and a Conference, Welcome Baby, Random Act of Kindness) ADRA has always encouraged creativity, innovation and imaginative thinking. Running these projects have helped us make new friends, learn new skills and most importantly, give back to the community.

Each one of us yearns to have a sense of purpose and direction. We all know that helping others does not only better other people's lives, but it also has a positive impact on our own lives in making us happier, more balanced, and instilling in us a greater sense of purpose. Running these community projects didn't only help us personally, but it helped our churches become more focused. It also offered an amazing opportunity to the team of volunteers to use their gifts and talents to give back to their community. These projects proved beneficial for the attendees and the volunteers' mental health and wellbeing by reducing stress, improving their emotional wellbeing, and even improving their physical health.

In the wake of the devastating Christchurch attacks, the Seventh-day Adventist Church in South New Zealand has offered their full support to the Muslim community. It was rewarding to serve our Muslim friends by organising a vigil of Christian churches, connecting with Imams, and visiting at the family centre. We also helped the youth department in running a kids club, women ministries in connecting with widows and victims, and taking part in organising the food hampers that were generously donated by ADRA, Sanitarium and the SNZC.

As I [Younis] look back, one thing is very clear to me — that we cannot undermine the power of connecting and serving our community. We don't have to wait until a crisis occurs to connect and start making a difference now.

We encourage pastors and churches to get involved by attending a Community Champions Workshop and partner with ADRA to run a CTP initiative that meets the needs of your community. Now is a good time to build friendships and trust with your community, so you can respond during times of need and be stronger together!

Report of the Internal Auditor on the Summary Financial Statements

To the Board of Trustees Adventist Development and Relief Agency Auckland, New Zealand

Opinion

The summary financial statements, which comprise the summary balance sheets as at 30 June 2019 and 2018 and the summary income statements for the years then ended, are derived from the audited financial statements of **Adventist Development and Relief Agency** ("the Organisation") for the years ended 30 June 2019 and 2018.

In our opinion, the summary financial statements derived from the audited financial statements of **Adventist Development and Relief Agency** for the years ended 30 June 2019 and 2018 are consistent, in all material respects, with those financial statements, on the bases described in Note 2.

Summary Financial Statements

The summary financial statements do not contain all the disclosures required by Public Benefit Entity Standards Reduced Disclosure Regime issued by New Zealand Accounting Standards Board (PBE IPSAS). Reading the summary financial statements and the auditor's report thereon, therefore, is not a substitute for reading the audited financial statements and the auditor's report thereon

The Audited Financial Statements and Our Report Thereon

We expressed an unmodified audit opinion on the audited financial statements in our report dated 29 October 2019. In our report dated 25 September 2018, our opinion on the 2018 financial statements was qualified because we understood there was not an effective system of internal control over the collection of donations and other fundraising activities, which resulted in our audit procedures being limited to amounts recorded. Subsequent to the date of that report, we gained a better understanding of controls over the collection of donations and other fundraising activities, which allowed us to conclude that amounts recorded, are presented fairly. Accordingly, our present opinion on the 2018 financial statements is different from that expressed in our previous report.

Board of Trustees' Responsibility for the Summary Financial Statements

The Board of Trustees' are responsible for the preparation of a summary of the financial statements in accordance with New Zealand Accounting Standards as applicable to not-for-profit organisations adopted by the Seventh-day Adventist denomination.

Auditor's Responsibility

Our responsibility is to express an opinion on whether the summary financial statements are consistent, in all material respects, with the audited financial statements based on our procedures, which were conducted in accordance with International Standard on Auditing (New Zealand) (ISA (NZ)) 810 (Revised), *Engagements to Report on Summary Financial Statements*.

Other than in our capacity as internal auditors of the Seventh-day Adventist Church, we have no relationship with, or interests in, **Adventist Development and Relief Agency**.
