

FROM THE C.E.O.

Kia Ora! In many ways the last financial year was one of the most challenging ADRA New Zealand has experienced.

Despite steady support from our private donors, many of our long-term government-funded projects came to an end, and with that, an important income stream was reduced. Early in the year, ADRA New Zealand reviewed its business model and priorities in order to understand external pressures and internal realities. Necessary organisational change followed.

This process has not been easy but thanks to a committed team, strong partnerships with organisations in New Zealand and abroad, and long-term commitment from our supporters, we have already seen signs of recovery.

Creating more opportunities for families to thrive is of high importance for us. Here in New Zealand, the already successful Community Transformation Partnership (CTP) initiatives were strengthened, with new initiatives such as Creation Health and the Depression and Anxiety Recovery Programme added to the portfolio. Thirty-three communities in New Zealand experienced the impact of these initiatives during the year.

Just before the end of the financial year, we learned that a recently submitted concept note for a five-year agriculture project in Timor-Leste, South-east Asia, was awarded. ADRA was then invited to work on a full proposal that will support more than 3,000 farmers and their families. We praise God for this opportunity.

Thanks to your support of our emergency appeals, and two successful government bids, ADRA New Zealand has this year supported famine relief projects in Somalia, enabling more than 1,500 internally displaced families to return to their homes and livelihoods after living in makeshift camps for months.

Throughout this report you will find a glimpse of how the lives of thousands of children and

their families have been transformed at home and overseas. Despite the challenges experienced this year, we remain inspired by the impact achieved and are strongly committed to seeing more lives changed.

With you, and the Almighty driving this agency, the journey ahead is certain!

Most importantly, we believe it will help impact the lives of more people both here in New Zealand and abroad.

Change is never easy, but it is our hope and prayer that God will continue to guide and bless us as we embark on this new chapter in ADRA New Zealand's history. The words of 1 Corinthians 15:58 offer wisdom and encouragement to us all, "Always give yourselves fully to the work of the Lord, because you know that your labour in the Lord is not in vain." OUR WORK OVERSEAS

In the past year over 90,000 people have been impacted by our work overseas through both ongoing development and disaster relief projects. Through the global ADRA network, ADRA New Zealand has the ability reach into 134 countries quickly. During this financial year we worked in seven countries around the world including responses to the East Africa famine crisis in Somalia, and providing education and health resilience for internally displaced people in Syria. Closer to home, we have worked closely with our partners in Fiji and Vanuatu for not only development programming, but also disaster response and recovery.

THEIN'S STORY

"About 10 years ago the weather was really good so we could survive from farming," says Thein, a generous-spirited father of four. "But now the weather is different and we can't grow enough to live."

Thein is one of hundreds of subsistence farmers who were invited to join an ADRA project in Myanmar to learn sustainable agriculture and farming techniques.

"ADRA helped us gain more knowledge and now we feel hopeful that life will get better. It may be too late for my sons to have a better life," he says, "But I have hopes that other children in the village will benefit from the ADRA project. I hope we can create jobs for them here instead of sending them away."

RAYNA'S STORY

"Rayna once shared water with her entire village. She also shared it with any animal that wandered into the stream. This left her family of young children vulnerable to water-borne diseases which often resulted in painful, energy-sapping and potentially deadly vomiting and diarrhoea.

That changed when Rayna's community joined ADRA's Water Health and Sanitation project in Vanuatu. Now, forty tap stands have been installed to provide clean, safe drinking water for 120 families.

She no longer spends long hours fetching water for her family; she is no longer vulnerable to danger from making the trip alone, and she no longer has to worry that her son Ryan will get sick from the water she gives him to drink.

OUR WORK AT HOME

As the number of families facing hardship continues to increase, we are committed to helping them not only survive, but thrive. These projects are operated in partnership with local Seventh-day Adventist Churches, whom we cannot thank enough for their commitment of time, energy and resource.

In the last 12 months we've helped families from 33 communities across the country through the following initiatives:



Paperbetter 1. The solutions me-skins programme targeting trose recently released from prison. 2. Debt, Job Search and Addiction recovery programmes in partnership with Christians Against Poverty (CAP), Whangaui — The Solutions life-skills programme targeting those recently released from prison, Royal Oak (Auckland) – A Community Meals programme providing free meals to local families, Kaitaia – Community Work programme which supports those looking for employment through work-experience and volunteer opportunities in the far-north, Nelson – The Accelerate programme provides holistic lifestyle workshops covering health, finances and relationships, Blenheim – Soup Kitchen providing free meals to local families.

The Choose Life Family Health

Programme provides resources and support for a number of initiatives that target specific health issues in New Zealand communities. This year we operated these initiatives in:

> Dargaville – Depression and Anxiety Recovery, Complete Health Improvement Programme (CHIP), Blenheim – Depression and Anxiety Recovery, Kaikohe – Oranga Kai Healthy Cooking Classes, Orewa – Living Well Vegetarian Cooking. The newly launched **Pathways initiative** is a driving instruction and road-safety programme that allows people without their license to obtain it and therefore gain better access to the job market and a range of social services.

The My Money Family

Budgeting initiative provides a free, transformational financial management programme through our partnership with the Commission for Financial Literacy. This past year we delivered these programs in:

OUR SUPPORTERS CONTINUED





Report of the Internal Auditor on the Summary Financial Statements

To the Board of Trustees Adventist Development and Relief Agency Auckland, New Zealand

Opinion

The summary financial statements, which comprise the summary balance sheets as at 30 June 2017 and 2016 and the summary income statements for the years then ended, are derived from the audited financial statements of **Adventist Development and Relief Agency** ("the Organisation") for the years ended 30 June 2017 and 2016. We expressed a qualified audit opinion on the audited financial statements in our reports dated 25 October 2017 and 23 November 2016

In our opinion, the summary financial statements derived from the audited financial statements of **Adventist Development and Relief Agency** for the years ended 30 June 2017 and 2016 are consistent, in all material respects, with those financial statements, on the bases described in Note 2. However, the summary financial statements are qualified to the equivalent extent as the audited financial statements of the Organisation for the years ended 30 June 2017 and 2016.

Summary Financial Statements

The summary financial statements do not contain all the disclosures required by New Zealand equivalents to International Financial Reporting Standards (NZ IFRS). Reading the summary financial statements and the auditor's report thereon, therefore, is not a substitute for reading the audited financial statements and the auditor's report thereon.

The Audited Financial Statements and Our Report Thereon

We expressed a qualified audit opinion on the audited financial statements in our reports dated 25 October 2017 and 23 November 2016. That report also includes a qualification of the audited financial statements, described in our qualified audit opinion, based on the fact that it is not practicable for the Organisation to maintain an effective system of internal control over the collection of donations and other fund raising activities until their initial entry into the accounting records of the Organisation. Accordingly, our audit of donations and other fund raising activities and donations was limited to amounts recorded.

Board of Trustees' Responsibility for the Summary Financial Statements

The Board of Trustees' are responsible for the preparation of a summary of the financial statements in accordance with New Zealand Accounting Standards generally accepted by the Seventh-day Adventist denomination.

Auditor's Responsibility

Our responsibility is to express an opinion on whether the summary financial statements are consistent, in all material respects, with the audited financial statements based on our procedures, which were conducted in accordance with International Standard on Auditing (New Zealand) (ISA (NZ)) 810 (Revised), *Engagements to Report on Summary Financial Statements*.

Other than in our capacity as internal auditors of the Seventh-day Adventist Church, we have no relationship with, or interests in, **Adventist Development and Relief Agency**.
