Message from our CEO

Connected, Courageous, Compassionate

During my time here at ADRA, it has been my absolute privilege and blessing to have built relationships with many of our Champions across Aotearoa. In supporting them to connect, serve and be the hands and feet of Jesus in their local communities, I am continually inspired by them as they too live out our ADRA values of being Connected – working collaboratively for the best outcome for those living in poverty or distress. Courageous – persevering through challenging situations and Compassionate – empathising with the communities we work with and with each other.

There's a quote by Theodore Roosevelt — "People don't care how much you know, until they know how much you care". Our National Programme is founded on good partnerships with our local Community Champions across Aotearoa who truly care about God and others. This year our Community Transformation Programme (CTP) saw the implementation of 25 projects to positively impact 5,423 people.

Earlier this year in January, a Disaster Ready Church (DRC) Coordinator position was created and taken up by Luana Tupou. Luana is passionate about serving God and others. She felt huge compassion for the devastating effects of Cyclone Gabriele and courageously volunteered to lead our Hawkes Bay Clean Up Crew response in June 2023. It was after this trip that her heart was moved to shift into this line of work. Little did we know that God was already moving and 7 months later Luana would be officially working at ADRA New Zealand to help equip churches in the areas of prevention, preparedness, recovery and response as part of the DRC initiative.

Ongoing networking and connecting with key stakeholders, while strengthening relationships with the Auckland Welfare Coordination Group (AWCG), National Emergency Management Agency (NEMA), Red Cross and Civil Defence Emergency Management (CDEM) continues.

In May, the third Equipped to Serve Champions Conference was the focal point, with extensive planning in partnership and coordination with our New Zealand Pacific Union Conference to include plenary speakers along with various workshops to equip Champions in connecting and serving their communities.

June marked a focus on expanding global connections and strategic planning for future DRC initiatives. Key discussions with ADRA Asia, ADRA International, and ADRA Australia revolved around the DRC logo for a global network, while ongoing efforts to integrate disaster response plans into churches.

The next steps will involve launching the Disaster Ready Church (DRC) programme with a DRC brochure that explains all the details about the available workshops, what the DRC entails, why it is necessary, and how it works. The vision is to connect churches with their neighbours and communities, so that when disaster strikes, there is already a foundation of trust. This will ensure that people can find those who care for them and will offer help in their greatest time of need.

Pathways Drivers Licensing Programme

The Pathways Drivers Licencing Programme has been running for 10 years. After a review of the programme, changes were made to the implementation of this programme via a few select schools from 2020 – ASDAH (Auckland Seventh-day Adventist High School), De La Salle College, Papatoetoe High School and Tangaroa College.

Learnings from the various programmes being run at churches and in the community, showed challenges for the coordinators, due to limited connection with the participants as many were not known personally to coordinators, making it difficult to follow up participants and restricting the success of the programme.

After a review of the overall programme and learnings, the shift was made to focus on a few schools in areas of need. Schools were identified with a committed teacher coordinator to the Pathways programme and where there were also many young people from vulnerable families or with very limited access to obtain their licence.

Once their learners licence has been obtained, they are also eligible to a few driving lessions to assist them on their way towards their restricted licence. These changes along with having teacher coordinators who see student participants on a much regular basis (almost daily) for follow up have provided a much better success rate of over 90%.

ADRA's support has provided the opportunity for over 600 young people via ASDAH, De La Salle College, Papatoetoe High School and Tangaroa College to obtain their learners and restricted licences to date and statistics show how this opens further opportunities for them in life.

Both teachers and students alike are always extremely thankful for the opportunity, especially as funding in this area has been cut down for many schools. "Thank you ADRA for this opportunity and for supporting our students, you are helping them to achieve their goals and dreams ..." – Mogi (teacher from De La Salle College).

As we continue to serve our communities through our CTP and DRC initiatives, we want to acknowledge all our wonderful and amazing Champions who courageously connect and serve with great compassion to see our communities thrive. We also are so thankful to the various funders and partners who provide the resources that allow us to continue doing the mahi that we love to make a real difference in the lives of those who need it most.

Story Spotlight

In response to the devastating Enga landslide in Yambali village in Papua New Guinea, ADRA, in collaboration with several partner organizations, mobilized a swift emergency relief effort. Heavy rainfall had triggered the landslide, causing widespread destruction, displacing over 4,000 individuals, and tragically claiming 206 lives. Roads were blocked, and communities were left isolated, making it difficult for rescue and recovery teams to reach the affected areas.

ADRA's emergency response team, along with local and international partners, initiated a six-day relief operation. They procured essential food and non-food items, overcoming significant logistical challenges to deliver life-saving aid to the region. Despite political and logistical obstacles, ADRA chose to work through local church networks to ensure fair and effective distribution of relief supplies, which was warmly received by the affected communities.

Through stakeholder engagement, the relief operation was able to provide support to displaced families.

In total, the relief efforts reached 710 individuals, including 376 children and 22 people with disabilities. ADRA's response not only provided immediate relief but also fostered hope and resilience, embodying the principles of justice, love, and compassion in the face of disaster.

The interventions included the following key actions:

- 1. Provision of Emergency Relief Supplies:
 - **Food Items:** These included staple foods to provide immediate nourishment to the affected individuals.
 - Non-Food Items: Critical non-food supplies such as blankets, clothing, and hygiene
 products were distributed to help families maintain basic living conditions in the
 aftermath of the disaster
- 2. Logistical Coordination and Distribution:
 - The ADRA team coordinated with local volunteers and church networks to ensure the fair and timely distribution of aid. They circumvented previous challenges in distribution caused by political interference by leveraging trusted local church groups for fair delivery to affected families.
- 3. Stakeholder Engagement:
 - ADRA collaborated with local and international stakeholders, including NGOs, local government, and the community, to consolidate efforts in delivering aid. This ensured a coordinated response and maximized the resources available for relief.
- 4. Psychological Support:
 - ADRA and its partners offered psychological support to help affected individuals, many
 of whom had lost family members, homes, and livelihoods. This support was critical in
 helping communities cope with trauma and begin the recovery process.

These interventions collectively aimed to provide immediate relief, restore a sense of stability, and support the long-term recovery of the affected communities.




